### EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this 25th day of January 1993, by and between Albany Towing Services, Inc., an Oregon Corporation, herein called Grantors, and the CITY OF ALBANY, a Municipal Corporation, herein called "City."

#### WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

A ten-foot wide permanent utility easement across that property described in Memorandum of Contract Sale recorded May 5, 1989 in MF Volume 499, Page 507, Linn County Microfilm Deed Records, five feet on either side of the centerline of the existing east-west sanitary sewer line across said parcel, more generally described as follows and as shown on the attached map labeled EXHIBIT A:

Beginning at the southwest corner of the intersection of Queen Avenue and Marion Street in the Southeast 1/4 of the Southwest 1/4 of Section 7, Township 11 South, Range 3 West, Willamette Meridian, City of Albany, Linn County, Oregon; thence southerly along the west right-of-way line of Marion Street 200.44 feet, more or less, to the intersection of said west right-of-way line with the east-west sanitary sewer line; thence North 89° 46' West, along the centerline of said sanitary sewer line, 317.0 feet to the intersection of said east-west sanitary sewer line and the easterly boundary of Albany Towing Services, Inc. parcel, said intersection being the TRUE POINT OF BEGINNING; thence continuing North 89° 46' West along the centerline of said east-west sanitary sewer line 188.65 feet to the west boundary of said Albany Towing Services, Inc. parcel and there terminating. The side lines of said ten-foot easement are to be extended or shortened to terminate in the east and west boundaries of said Albany Towing Services, Inc. parcel.

Containing 0.043 acres, more or less.

- 2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.
- 3. The easement granted is in consideration of \$1.00 and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.
- 4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.

- 6. No permanent structure shall be constructed on this easement.


