## RESOLUTION NO. 3447

A RESOLUTION SETTING ALL MONETARY VALUES, INCLUDING BUT NOT LIMITED TO FEES, CHARGES, OR FINES FOR THE ALBANY MUNICIPAL CODE, TITLES 6, 7, 9, 10, 11, 13, 14, 15, 17, AND 18, AND REPEALING RESOLUTION NO. 3433.

WHEREAS, the Albany Municipal Code contains monetary values for the purpose of such things as recovery of administrative and other expenses; and

WHEREAS, the Albany Municipal Code, Titles 6, 7, 9, 10, 11, 13, 14, 15, 17, and 18, were revised in such a manner as to set all monetary values, including but not limited to fees, charges, or fines by Council resolution.

NOW, THEREFORE, BE IT RESOLVED that Resolution No. 3433 is hereby repealed.

BE IT FURTHER RESOLVED that the Albany City Council, a Municipal Corporation of the State of Oregon, sets the following monetary values in the corresponding Albany Municipal Code sections:
