#### EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this 3 day of 5 day of

#### WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

<u>TRACT 1:</u> A 15.00 foot-wide permanent public utility easement (for a water line) across a portion of that parcel conveyed to Jack Keller and Agnes C. Keller by deed recorded in Volume 631, Page 409, Linn County Microfilm Deed records, said easement being more particularly described as follows and as shown on the attached map labeled Exhibit A:

Beginning at a point on the south right-of-way line of vacated Oak Street, which point is 587.16 feet South 1° 40' 32" East, 30.00 feet South 88° 19' 28" West, and 318.44 feet North 52° 28' 49" West of the Northeast Corner of the C. D. Burkhart Donation Land Claim No. 52 in Township 11 South, Range 3 West of the Willamette Base and Meridian, Linn County, Oregon; and running thence South 37° 31' 11" West 16 feet and there terminating.

- 3. The easement granted is in consideration of \$1.00 and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.
- 4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
- 5. Upon performing any maintenance, the City shall return the site to original or better condition.
- 6. No permanent structure shall be constructed on this easement.


