EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this ____ day of _____, 199%, by and between Joseph D. Stauffer, herein called Grantors, and the CITY OF ALBANY, a Municipal Corporation, herein called "City."

WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

A variable-with permanent public utility easement across that parcel conveyed to Joseph D. Stauffer by deed recorded in Volume 148, Page 240, Linn County Microfilm Deed Records, said easement being more particularly described as follows and as shown on the attached map labeled Exhibit A:

Beginning at a 5/8-inch iron rod, said rod being the Northwest corner of the Isaac Hutchins Donation Land Claim No. 85 in the Northwest quarter of Section 13, Township 11 South, Range 4 West of the Willamette Meridian in Linn County, Oregon; thence North 89° 02' 58" West, along the North line of the Jarvis Briggs Donation Land Claim No. 83, said Section, Township, and Range, 25.24 feet to a 5/8-inch iron rod; thence North 10° 48' East 936.02 feet to a point; thence North 41° 17' 58" West 435.05 feet to the TRUE POINT OF BEGINNING; thence North 10° 54' 00" East 31.64 feet to a point; thence North 41° 17' 58" West 69.11 feet to a point; thence South 89° 02' 36" West 39.20 feet to a point; thence South 51° 33' 39" West 20.15 feet to a point; thence South 41° 17' 58" East 134.28 feet to a point; thence North 10° 54' 00" East 31.64 feet to the True Point of Beginning. 

The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
- 5. Upon performing any maintenance, the City shall return the site to original or better condition.
- 6. No permanent structure shall be constructed on this easement.
