EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this day of flug., 1995, by and between Clem H Reding and Leroy Mary, herein called Grantors, and the CITY OF ALBANY, a Municipal Corporation, herein called "City."

WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

A permanent public utility easement across that tract conveyed to Grantors by deed recorded in Volume 425, Page 492, Linn County Microfilm Deed Records, said easement being more particularly described as follows and as shown on the attached map labeled Exhibit A:

Beginning at the northeast corner of the South half of Lot 6, John Millard's Plat in Section 7, Township 11 South, Range 3 West, Willamette Meridian, Linn County, Oregon; thence South 88° 30' 30" West 206.00 feet to a 5/8-inch iron rod; thence along the east right-of-way line of U. S. Highway 99E (Pacific Blvd.) North 30° 06' 14" East 35.50 feet to a 1/2-inch iron rod; thence South 64° 55' 48" East 347.84 feet to a 1/2-inch iron rod at the northeast corner of said Volume 425, Page 492, said point being the TRUE POINT OF BEGINNING; and running thence North 64° 55' 48" West 27.08 feet; thence South 08° 58' 30" East 115.71 feet; thence North 81° 01' 13" East 22.44 feet; thence North 08° 58' 30" West 100.54 feet to the TRUE POINT OF BEGINNING.

Containing 2426 square feet of land, more or less.

- 2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.
- 3. The easement granted is in consideration of \$1.00 and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.
- 4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
- 5. Upon performing any maintenance, the City shall return the site to original or better condition.
- 6. No permanent structure shall be constructed on this easement.


