#### EASEMENT FOR PUBLIC UTILITIES

#### WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

The north 5.00 feet of even width of Lots 4 and 5, Block 6 of the Epauline Addition to the City of Albany; otherwise described as the north 5.00 feet of Tax Lot 7700, Linn County Assessor's Map No. 11-3W-07DB. (Linn County Microfilm Deed Records Volume 597 page 975).  $(100^{\circ} \times 5.00^{\circ}) = 500$  square feet, more or less. See attached map labeled Exhibit A.


