RESOLUTION NO. 3559

RESOLUTION AMENDING PARKING RESTRICTIONS WITHIN THAT AREA OF DOWNTOWN ALBANY WHERE PARKING ON PUBLIC STREETS IS ENFORCED AND MANAGED BY THE ALBANY DOWNTOWN ASSOCIATION

WHEREAS, the Albany Downtown Association has been authorized by the City to provide management and enforcement services for parking in the downtown area of the City of Albany; and

WHEREAS, the Albany Downtown Association has requested certain modifications to parking restrictions for various parking spaces in order to provide a more efficient utilization of parking resources.

NOW, THEREFORE, BE IT RESOLVED that the following changes in parking restrictions are hereby established as follows:

- 1. Change west side of Ferry Street, between 1st Avenue and Water Street, from "3 Hour Customer Only" to "All Day Customer Employee Permit" parking.
- 2. Change the west six parking spaces on the south side of 1st Avenue between Ferry Street and Broadalbin Street from "3 Hour Customer Only" to "All Day Customer Employee Permit" parking.
- 3. Change the north four parking spaces on the west side of Broadalbin Street between 1st Avenue and 2nd Avenue from "3 Hour Customer Only" to "All Day Customer Employee Permit" parking.
- 4. Change the east four parking spaces on the south side of 2nd Avenue between Washington Street and Ferry Street from "3 Hour Customer Only" to "All Day Customer Employee Permit" parking.
- 5. Change north two parking spaces on the west side of Ferry Street between 2nd Avenue and 3rd Avenue from "All Day Customer Employee Permit" to "30 Minute" parking.
- 6. Change west four parking spaces on the south side of 2nd Avenue between Ferry Street and Broadalbin Street from "3 Hour Customer Only" to "All Day Customer Employee Permit" parking.
- 7. Change east three parking spaces on the south side of 2nd Avenue between Ellsworth Street and Lyon Street from "3 Hour Customer Only" and "10 Minute" to "All Day Customer Employee Permit" parking.
- 8. Change the east two parking spaces on the south side of 1st Avenue between Ellsworth Street and Lyon Street from "3 Hour Customer Only" to "All Day Customer Employee Permit" parking.
- 9. Change the most westerly parking space on the north side of 2nd Avenue between Ferry Street and Broadalbin Street from "3 Hour Customer Only" to "30 Minute" parking.
- 10. Change the most easterly parking space on the north side of 2nd Avenue between Ferry Street and Broadalbin Street from "3 Hour Customer Only" to "30 Minute" parking.
