

#### EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this 17th day of July, 1995, by and between Vernon Schrock, Leona Schrock, Dean Schrock, and Kathleen Schrock, herein called Grantors, and the CITY OF ALBANY, a Municipal Corporation, herein called "City."

#### WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

A PARCEL OF LAND FOR UTILITY PURPOSES LOCATED IN THE NORTHEAST ONE-QUARTER (1/4) OF SECTION 36, TOWNSHIP 11 SOUTH, RANGE 4 WEST, WILLAMETTE MERIDIAN, LINN COUNTY, OREGON, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A 5/8 INCH IRON ROD WHICH BEARS SOUTH 63° 08' 13" WEST 84.37 FEET FROM THE NORTHEAST CORNER OF SECTION 36, SAID IRON ROD ALSO MARKS THE INTERSECTION OF THE SOUTHERLY RIGHT-OF-WAY OF BETA DRIVE AND THE WESTERLY RIGHT-OF-WAY OF HIGHWAY 99E AND A POINT ON A 40.00 FOOT RADIUS CURVE TO THE LEFT; THENCE 35.60 FEET NORTHWESTERLY ALONG THE ARC OF SAID CURVE AND SAID SOUTHERLY RIGHT-OF-WAY OF BETA DRIVE (LONG CHORD BEARS NORTH 60° 06' 22" WEST 34.40 FEET); THENCE SOUTH 02° 15' 12" WEST LEAVING SAID RIGHT-OF-WAY 24.97 FEET; THENCE SOUTH 87° 44' 48" EAST 30.50 FEET TO THE AFOREMENTIONED HIGHWAY 99E RIGHT-OF-WAY; THENCE NORTH 02° 15' 12" EAST ALONG SAID RIGHT-OF-WAY 9.00 FEET TO THE POINT OF BEGINNING.

CONTAINING 0.014 ACRES OF LAND, MORE OR LESS. THE BASIS OF BEARINGS FOR THIS EASEMENT DESCRIPTION IS LINN COUNTY PARTITION PLAT NO. 1995-32.

- 2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.
- 3. The easement granted is in consideration of \$1.00 and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.
- 4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
- 5. Upon performing any maintenance, the City shall return the site to original or better condition.


