## EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this 20 day of February, 1996, by and between Denis H. Derksen and Rachel L. Derknen, herein called Grantors, and the CITY OF ALBANY, a Municipal Corporation, herein called "City."

## WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

The easterly 15.00 feet of even width of that Derksen Tract described by deed recorded in M-131703-91 of the Benton County Deed Records on February 4, 1991, EXCEPTING THEREFROM the easterly 7.00 feet of even width. The above strip therefore being 8.00 feet in width and more particularly described as follows and as shown on the attached map labeled Exhibit A:

Beginning at a $5 / 8$ inch rod on the north line of said Derksen Tract, which point is South $00^{\circ} 07^{\prime} 40^{\prime \prime}$ East 597.96 feet and South $89^{\circ} 46^{\prime} 32^{\prime \prime}$ East 720.83 feet from the northwest comer of the J. Q. Thornton Donation Land Claim No. 37 in Township 10 South, Range 4 West, Willamette Meridian, Benton County, Oregon; thence North $89^{\circ} 466^{\prime} 32^{\prime \prime}$ West, along the said north line of Derksen Tract, 8.00 feet; thence South $00^{\circ} 12^{\prime} 00^{\prime \prime}$ East 149.49 feet to the south line of said Derksen Tract; thence South $89^{\circ} 46^{\prime} 33^{\prime \prime}$ East, along the south line of said Derksen Tract, 8.00 feet to a $5 / 8$ inch rod; thence North $00^{\circ} 12^{\prime} 00^{\prime \prime}$ West 149.49 feet to the Point of Beginning.
2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.
3. The easement granted is in consideration of $\$ 1.00$ and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.
4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
5. Upon performing any maintenance, the City shall return the site to original or better condition.

6. No permanent structure shall be constructed on this easement.
