#### **DEDICATION DEED**

KNOW ALL MEN BY THESE PRESENTS, that Charles R. Means and Margaret C. Means, hereinafter referred to as the Grantor, does dedicate to the City of Albany for street and utility right-of-way purposes, all that real property situated in Linn County, State of Oregon, described as follows:

All that portion of Parcel 2 of PARTITION PLAT NO. 1995-34, a partition of record in Linn County, Oregon that lies south of the north line of said Parcel 2 and lies north of the north line of PARTITION PLAT NO. 1996-71, a partition of record in Linn County, Oregon, said portion of Parcel 2 being more particularly described as follows and as shown on the attached map labeled Exhibit A:

Beginning at a 5/8 inch rod located at the intersection of the north line of said Parcel 1 with the west right-of-way line of South Marion Street (a 60.00 foot wide right-of-way), which point being North 88° 58' 16" East 685.15 feet, North 01° 11' 22" West 4119.39 feet and South 89° 45' 49" East 652.38 feet from the southwest corner of the Hiram N. Smead Donation Land Claim No. 53 in Township 11 South, Range 3 West, Willamette Meridian, Linn County, Oregon; thence North 89° 45' 49" West, along the north line of said Parcel 1, a distance of 487.38 feet to a 5/8 inch rod; thence North 01° 09' 15" West 13.00 feet to a 5/8 inch rod; thence South 89° 45' 49" East 472.01 feet to a 5/8 inch rod; thence along the arc of a 15.00 foot radius curve to the left (chord bears North 58° 55' 49" East 15.59 feet) a distance of 16.39 feet to a 5/8 inch rod on the south line of that Gordon Tract described by deed recorded in Microfilm Volume 753, Page 650 of the Linn County Deed Records on June 27, 1995; thence South 89 20' 17" East, along the south line of said Gordon Tract, 1.86 feet to the said west right-of-way line of South Marion Street; thence south 01° 10' 03" East 21.09 feet to the Point of Beginning.

and covenants that the Grantor is the owner of the above described property free of all encumbrances save and except reservations in patents and easements of record, and will warrant and defend the same against all persons who may lawfully claim the same.

The deed granted herein is in consideration of \$1.00 and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom. Nothing herein shall reduce or limit grantors obligation to pay any costs or assessments which may result from the improvements.


