PERMANENT PUBLIC UTILITY EASEMENT

The undersigned, Angela Spalt, Grantor do hereby grant to City Albany, Linn County, Oregon, a municipal corporation, referred to herein as City, a permanent right-of-way and exclusive easement to construct, reconstruct, operate and maintain City storm sewer and all necessary related facilities under and along the following described premises:

See "Exhibit A", incorporated herein for legal description. See "Exhibit B", incorporated herein for exhibit map.

TO HAVE AND TO HOLD said easement and right-of-way unto said City, its successors and assigns.

The permanent right-of-way or easement shall include the right, privilege, and authority of City to excavate for, and to construct, install, lay, operate, maintain and remove underground pipelines with all appurtenances incident thereto or necessary thereafter, for the purpose of supplying public utility service under and across the said premises, together with the right of City to place, install, maintain, inspect, add to the number of and relocate pipelines and/or cables and necessary appurtenances and make excavations therefore from time to time, in, under and through the above described premises within said right-of-way, and to cut and remove from said right-of-way any trees and other obstructions which may endanger the safety or interfere with the use of said pipelines or appurtenances attached to or connected therewith; and the right of ingress and egress to and over said above described premises at any and all times for the purpose of patrolling the pipelines or repairing, renewing or adding to the number of pipelines and appurtenances and for doing anything necessary, useful or convenient for the enjoyment of the easement hereby granted. Upon the final acceptance of the installed system by the City, the City shall be responsible for all further restorations of the premises if at any time the City causes the utilities to be repaired or maintained. No trees, permanent structures or improvements, including parallel fences, other than those already in existence or allowed herein, shall be placed or constructed on the easement by the Grantor or the Grantor's heirs, assigns or successors in interest. Not withstanding anything to the contrary herein, Grantor shall have the right to improve the area described in Exhibit A and B by paving said area with asphalt or similar material. The City, upon each and every occasion that the same be repaired, maintained or removed shall restore the premise of the Grantor, by removing all debris and leaving the ground surface in a neat and presentable condition. Grass, topsoil and asphalt shall be restored as near as




