KNOW ALL MEN BY THESE PRESENTS, that <u>Urs Dietrich</u>, as <u>Trustee of Alegan Foundation</u>, a <u>Liechtenstein Trust</u>, hereinafter stated, does hereby grant, bargain, sell and convey unto the **CITY OF ALBANY**, a municipal corporation, hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Linn, State of Oregon, described as follows, to-wit:

A parcel of land located in the southeast one-quarter (1/4) of Section 7, Township 11 South, Range 3 West, Willamette Meridian, City of Albany, Linn County, Oregon, more particularly described as below and as shown on the attached map labeled Exhibit A.


