#### EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this 11 the day of July , 1997, by and between Timothy D. Bartel and Joyce M. Bartel, herein called Grantors, and the CITY OF ALBANY, a Municipal Corporation, herein called "City."

#### WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

The right-of-way hereby granted consists of: 1.

> A parcel of land being a portion of Quarter Section 24, Township 11 South, Range 3 West, Willamette Meridian, Map 8CC, Lot 101, at the Northeast Corner of C.D. Burkhart Donation Land Claim No. 52, Linn County, Oregon, described as follows and as shown on the attached map labeled "Exhibit A".

> Beginning at the bolt (C.S. 570), at the NE Corner of C.D. Burkhart DLC No. 52, thence 51.98' West bearing S 88° 53' W, thence 40' South, bearing S 1° 38' E, to the NE Corner of said Lot 101, thence 21.34' Southeast, bearing S 46° 12' 30" E, thence 7.34' South, bearing S 1° 38' E, thence 4' West, bearing S 88° 22' W, thence 27.54' Northwest bearing N 46° 12' 30" W, thence 3' North, bearing N 1° 38' W, thence 8.33' East, bearing N 88° 53' E, to the point of beginning.

Containing 222.67 Square Feet.

The basis of bearings is County Survey 11751.


- 2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.
- 3. The easement granted is in consideration of \$350.00, receipt of which is acknowledged by the Grantor, and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.
- 4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
- 5. Upon performing any maintenance, the City shall return the site to original or better condition.
- 6. No permanent structure shall be constructed on this easement.
