EASEMENT FOR PUBLIC UTILITIES

WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantor has this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

A permanent Pubic Utility Easement across that property conveyed to Deed recorded in Volume 657, Page 981 and Volume 665, Page 304 Linn County microfilm deed records, said easement being more particularly described as follows and as shown on the attached Exhibit A and generally located as described on the attached Exhibit B and Exhibit C: An easement for a public waterline, the bounds of which are described as follows: Beginning at the Southwest corner of that Drushella property described in Linn County Records Volume 375 Page 81; thence along the West line of said Drushella property North 19°21'00" East 18.37 feet; thence North 70°39'00" West 25.00 feet to the East line of that Austin property described in Linn County Records Volume 538 Page 163; thence along said East line South 19°21'00" West 23.37 feet to the Southeast corner of said Austin property, said Southeast corner also being on the Northerly right-of-way line of State Highway 20; thence along the Northerly right-of-way line of State Highway 20 South 81°57'43" East 25.50 feet to the point of beginning, said easement containing 522 square feet, more or less. See attached Exhibit A.

- 2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.
- 3. The easement granted is in consideration of \$1.00, receipt of which is acknowledged by the Grantor, and in further consideration of the public improvements to be placed upon said property and the benefits grantor may obtain therefrom.
- 4. The Grantor does hereby covenant with the City that he is lawfully seized and possessed of the real property above described and that he has a good and lawful right to convey it or any part thereof and that he will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
- 5. Upon performing any maintenance, the City shall return the site to original or better condition.
- 6. No permanent structure shall be constructed on this easement.




EXHIBIT A





EXHIBIT B AREA MAP
