## RESOLUTION NO. 4052

A RESOLUTION DIRECTING AN ENGINEER'S REPORT AND A FINANCIAL INVESTIGATION REPORT BE PREPARED FOR CONSTRUCTION OF STREET IMPROVEMENTS ON PROPERTY LOCATED AT COLUMBUS STREET, BETWEEN 47TH AVENUE AND THE RAILROAD TRACKS TO THE NORTH.

WHEREAS, the street along the frontage of Columbus Street, between 47<sup>th</sup> Avenue and the railroad tracks, is unimproved to City standards; and

WHEREAS, the property owners representing approximately 82 percent of the affected property have submitted a petition for street improvements to be constructed on said property; and

WHEREAS, the property owners have requested consideration to use Bancroft funds for these public improvements; and

WHEREAS, Subsection 15.04.010 of the Albany Municipal Code requires the City Council to declare by resolution that it intends to make said improvements.


