EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this 21 day of 51, by and between Cummings transfer Co., an Oregon Corporation, Alton E. Sullivan & Dixie G. Sullivan, M&M Rentals Co., an Oregon Corporation, and Intermediary, Inc. an Oregon Corporation, herein called "Grantors", and the CITY OF ALBANY, a Municipal Corporation, herein called "City."

WITNESSETH:


That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.


This agreement is subject to the following terms and conditions:

- 1. The right-of-way hereby granted consists of:
 Beginning at a 5/8" iron rod which bears South 19°26'00" East 455.93 feet, North 62°44'42" East
 309.67 feet and North 61°12'52" East 56.89 feet from the intersection point of the East line of Lot
 1 in Block 4 of Kurre Lakeside Tracts City of Albany Linn County; Oregon and the South right of
 way of the Southern Pacific Railroad, said point being on the centerline of a 30.00 foot; public
 utility easement who's Southerly sidelines terminate at the Northerly edge of the right -of -way of
 Old Salem Ave; thence from said 5/8 iron rod North 21°38' 24" West along the centerline of said
 Easement 473.16 feet; thence South 71°43'38" West 37.35 feet; thence North 37°28'09" West 12.12
 feet. The Northerly sidelines of said easement are to terminate at the Southerly right-of-way of the
 Southern Pacific Railroad.
- 2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.
- 3. The easement granted is in consideration of \$1.00, receipt of which is acknowledged by the Grantor, and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.
- 4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
- 5. Upon performing any maintenance, the City shall return the site to original or better condition.
- 6. No permanent structure shall be constructed on this easement.
