#### **EASEMENT FOR PUBLIC UTILITIES**

TAXES: EXEMPT

THIS AGREEMENT, made and entered into this 13 day of January, 2000, by and between Rodney W. Randy Tripp, herein called Grantors, and the CITY OF ALBANY, a Municipal Corporation, Tripp herein called "City."

#### WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

- 1. The right-of-way hereby granted consists of: Beginning at a point that is the Northeast corner of Lot 3, Block 6, Eastgate Park Subdivsion, City of Albany, Linn County, Oregon, Section 9, Township 11 South, Range 3 West, of the Willamette Meridan, point being on the West right-f-way line of Interstate No. 5, thence South 89°45'30" West 150.03 feet to a point on the East line of Lehigh Way right-of-way; thence along East line of said right-of-way on a curve to the right with a raduis of 1600 feet which chord bears South 38°48'39" West 19.32 feet to a point on said right-of-way; thence North 89°45'30" East 162.24 feet to a point on the West right-of-way line of Interstate No.5; thence along said right-of-way line North 0°23'30" West 15.00 feet to the point of beginning.
- 2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.
- 3. The easement granted is in consideration of \$1.00, receipt of which is acknowledged by the Grantor, and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.
- 4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
- 5. Upon performing any maintenance, the City shall return the site to original or better condition.
- 6. No permanent structure shall be constructed on this easement.




