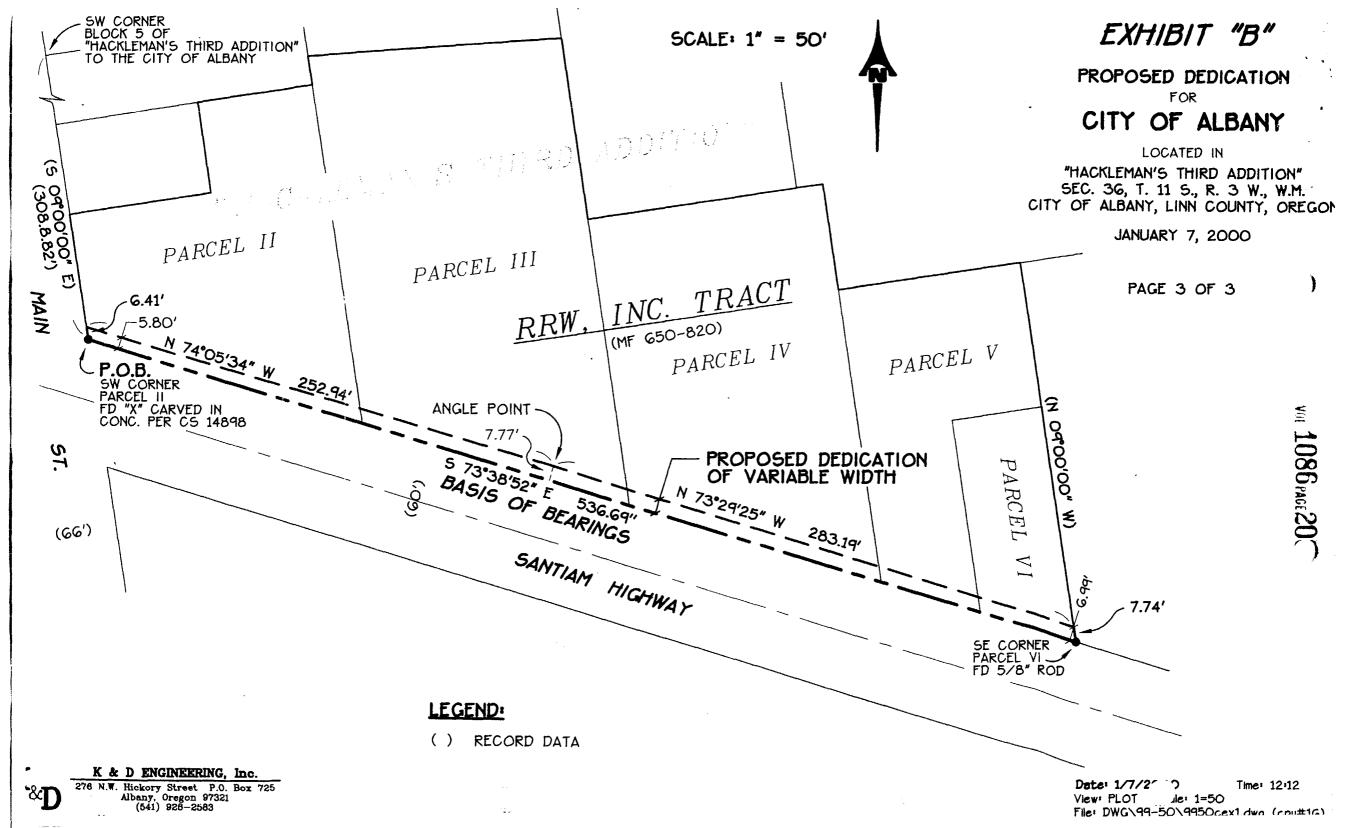

EXHIBIT "A"
