A RESOLUTION PROPOSING ANNEXATION OF PROPERTY AT 1650 QUEEN AVENUE SW (AN-03-99) AND FORWARDING THE QUESTION OF ANNEXATION TO THE VOTERS ON THE MAY 16, 2000 BALLOT.

THE CITY COUNCIL OF THE CITY OF ALBANY resolves that the findings contained in Exhibit A (which consists of the complete staff report to the Albany City Council, including attachments, and dated February 28, 2000 (File No. AN-03-99), and by this reference incorporated herein, are hereby adopted.

THE CITY COUNCIL OF THE CITY OF ALBANY FURTHER RESOLVES that the 1650 Queen Avenue SW annexation, which would annex approximately 0.17 acres of property located south of Queen Avenue SW, west of Broadway Street, all within Linn County, Oregon, to be zoned RS-6.5 (Single Family Residential), is to be submitted to the legal voters of Albany, Oregon, for their approval or rejection pursuant to Albany City Charter Chapter 54 at an election to be held on May 16, 2000. This election will be conducted by mail-in ballots.
