WELLHEAD PROTECTION EASEMENT

THIS EASEMENT, granted this <u>12</u> day of <u>March</u> 2003 by the **City of Albany**, a Municipal Corporation, herein called "Grantor," to the **GRAND PRAIRIE WATER SUPPLY COMPANY**, herein called "Grantee."

WITNESSETH:

The Grantor has this day bargained and sold and by these presents does bargain, sell, convey, and transfer unto the Grantee, easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain, repair and protect well facilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

A 100-foot radius wellhead protection easement, more particularly described in attached EXHIBIT "A" and shown in attached EXHIBIT "B."

- 2. The easement described herein grants to the grantee, the right to enter upon said easement at any time that it may see fit for construction, maintenance, evaluation, and/or repair purposes.
- 3. The Grand Prairie Water Supply Company shall have the right to restrict the placement of any structures, objects, including fill, vehicles, debris, non-approved herbicides, petroleum products, or other contaminants by anyone within this wellhead protection easement.
- 4. This easement shall not prevent the Grand Prairie Water Control District from performing standard maintenance activities along Periwinkle Creek.
- 5. This easement shall automatically terminate if the well is no longer used to supply water to the Grand Prairie Subdivision by the Grand Prairie Water Supply Company or its successor.



Legal Description for Wellhead Protection Easement:


