WHEREAS, the Parks Director has negotiated a private sale with the owner of the adjoining property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Albany that the City Manager is authorized and directed to sell Lot 1, Block 5, in Freeway Addition to the City of Albany to Marvin W. Coats and Martha W. Coats for the sum of \$12,000.


