RESOLUTION NO. 5103

A RESOLUTION DECLARING A NECESSITY THAT THE CITY ACQUIRES CERTAIN REAL PROPERTY LOCATED IN THE CITY OF ALBANY, BENTON COUNTY, OREGON, FOR THE PURPOSE OF CREATING A PUBLIC RIGHT-OF-WAY AND DECLARING AN EMERGENCY.

WHEREAS, the City is attempting to negotiate a private purchase from the owners of real property as described in the attached legal descriptions, which by this reference are incorporated herein as Exhibits 1, 2, 3, 4, 5, 6, and 7; and

WHEREAS, the property in question is necessary for the purpose of creating a public right-of-way in connection with the development of certain real property.

NOW, THEREFORE, BE IT RESOLVED that the City of Albany be and are hereby authorized to continue to negotiate an agreement with the owners and other persons of interest in the real property described in Exhibits 1, 2, 3, 4, 5, 6, and 7, located in the city of Albany, Benton County, Oregon; and in the event that no satisfactory agreement can be reached, then the City of Albany be and the same hereby are directed and authorized to commence and prosecute to final determination such proceedings as may be necessary to acquire said real property and interest therein may be taken immediately. The subject property is necessary for creation of a public right-of-way in connection with the development of certain real property, and the proposed use is located in a manner which will be most compatible with the greatest public good and the least private injury; and

BE IT FURTHER RESOLVED that immediate possession of the property is necessary and in the public interest.

<u>Emergency Clause</u>. In as much as this resolution is necessary for the immediate preservation of the public peace, health, and safety of the city of Albany, an emergency is hereby declared to exist; and this resolution shall take effect and be in full force and effect when signed by the Mayor.
