





Station 31+27.04); Thence North 6°12'06" West 74.86 feet to the beginning of a 0°30' curve to the right, (P.C. Station 36+65.00); Thence North 3°53'10" West 1083.05 feet to the beginning of a 21° curve to the left, (P.C. Station 47+48.05); Thence along the arc of said curve, the P.I. of which is monumented by a 5/8" iron rod and plastic cap stamped "Benton County Survey" as shown on C.S. 7508, through a central angle of 28°32'52", 135.94 feet (P.T. Station 48+83.99); Thence North 32°26'02" West 1.76 feet to the beginning of a 32° curve to the right, (P.C. Station 48+85.75); Thence along the arc of said curve, the P.I. of which is monumented by a 5/8" iron rod and plastic cap stamped "Benton County Survey" as shown on C.S. 7508, through a central angle of 17°04'39", 53.37 feet (P.T. 
