To Have and to Hold the same unto said CITY OF ALBANY, OREGON and its successors and assigns forever.




## Legal Description of portion of Easement being Terminated/Abandoned

A portion of a 15.00 foot wide easement that was granted to the City of Albany by a deed recorded in Linn County Microfilm Deed records Volume 870 Page 912, the centerline of said 15.00 foot wide terminated easement over an existing sewer line being more particularly described as follows:

Beginning at a point on the Easterly right-of-way line of Jackson Street ( a 66.00 foot wide right-ofway) that is South 09°18' West 52.73 feet and North 09°05' West 575 feet from the INITIAL POINT of "WINONA PARK SUBDIVISION", a subdivision of record in Linn County, Oregon; thence South 86°40'26" East 94.92 feet; thence North 09°20'57" West 7.5 feet to the **TRUE POINT OF BEGINNING**; thence continuing North 09°20'57" West 214.27 feet; thence North 80°51'17" East 249.54 feet to a manhole at the end of said sewer line; thence continuing North 80°51'17" East 7.5 feet to the terminus of the herein described easement being abandoned. 
