Beginning at a point which is the Southwest corner of Lot 18, Block 5 of the Supplemental Plat to a Portion of Blocks 2 & 5, Britewood Subdivision; thence South 89° 58' 15" West, 458.25 feet along the right-of-way line of 21st Avenue to the East subdivision boundary of the 2nd Supplemental Plat to Meadowview Addition; thence South 2° 04' 06" East, 30 feet along the East line of said 2nd Supplemental Plat to Meadowview Addition to the Northeast corner of Lot 1 Block 2 of said 2nd Supplemental Plat to Meadowview Addition; thence North 89° 58' 15" East, 458.25 feet; thence North 2° 4' 06" West, 30 feet to the point of beginning. Lying in Section 8 of Township 11 South in Range 3 West of Willamette Meridian, City of Albany, Linn County, Oregon as shown on the attached map labeled Exhibit A.

The Grantor covenants that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the same against all persons who may lawfully claim the same.


