### UNDERGROUND ELECTRICAL POWER EASEMENT, 34TH AVENUE SEWER PUMP STATION

THIS EASEMENT, granted this 11th day of February 2009 by the City of Albany, a Municipal Corporation, herein called "Grantor," to PacificCorp, an Oregon Corporation, its successors and assigns, herein called "Grantee."

#### WITNESSETH:

For value received, the Grantor hereby grants an easement and right-of-way, 10 feet in width and 85 feet in length, more or less, the right to enter upon the real property hereinafter described, for construction, reconstruction, operation, maintenance, repair, replacement, enlargement, and removal of Grantee's underground electric distribution and communication lines, including without limitation: wires, fibers, cables and other conductors and conduits therefore; and pads, transformers, switches, cabinets, vaults on across or under the surface of the real property of Grantor in Linn County, State of Oregon, as more particularly described as follows and/or as shown on Exhibit A attached hereto and by this reference made a part hereof:

An easement to allow access to Pacific Power to construct and maintain their facilities across that City of Albany property described in Linn County Deed Records MF5-699. The property and easement are further described on the attached schematic and maps labeled Exhibits A, B, C, and D.

Together with the right of access, for Grantee, its contractors, or agents, to the right of way from adjacent lands of the Grantor for all activities in connection with the purposes for which this easement has been granted; and together with the present and (without payment therefore) the future right to keep this right of way clear of all brush, trees, buildings and other hazards which might endanger the Grantee's facilities or impede Grantee's activities.

At no time shall the Grantor place or store flammable materials (other than agricultural crops), or light any fires, on or within the boundaries of the right of way. Subject to the foregoing limitations, the surface of the right of way may be used for agricultural crops and other purposes not inconsistent, as determined by Grantee, with the purposes for which this easement has been granted.

The rights and obligations of the parties hereto shall be binding upon and shall benefit their respective heirs, successors and assigns.




