#### WITNESSETH:

The Grantor has this day bargained and sold and by these presents does bargain, sell, convey, and transfer unto the Grantee, and grantee's heirs, successors and assigns, an ingress and egress easement and right-of-way, including the right to enter upon the real property hereinafter described, for the purpose of accessing and maintaining a sanitary sewer pipe and manhole.

This agreement is subject to the following terms and conditions:

- 1. The right-of-way hereby granted consists of:
  - A blanket access easement over the property described in attached EXHIBIT "A" and shown on the maps in attached EXHIBIT "B" and Exhibit "C".
- 2. The easement described herein grants to the grantee, the right to enter upon said easement at any time that it may see fit for inspection, construction, maintenance, evaluation, and/or repair purposes of the sanitary sewer system.
- 3. The easement is not an exclusive easement. The grantor reserves the right to build structures and place utilities within the easement area and grant easements to others over all or portions of the easement area, as long as the grantee retains maintenance vehicle access between Highway 20 and the sanitary sewer manhole along the northeast property line of the site.






