WITNESSETH:

For value received, the Grantor hereby grants an easement and right-of-way, 15 feet in width and approximately 72 feet in length, the right to enter upon the real property hereinafter described, for construction, reconstruction, operation, maintenance, repair, replacement, enlargement, and removal of Grantee's underground electric distribution and communication lines, including without limitation: wires, fibers, cables and other conductors and conduits therefore; and pads, transformers, switches, cabinets, vaults on across or under the surface of the real property of Grantor in Linn County, State of Oregon, as more particularly described as follows and/or as shown on Exhibit A attached hereto and by this reference made a part hereof:

A 15-foot wide by approximately 72 foot long easement, the centerline of which is described as follows: Beginning at a point on the south property line of Parcel "A" of the Supplemental Plat to Lots 4, 5, and 6 of Block 1, College Green in the Northeast Quarter of Section 25, Township 11 South, Range 4 West, Willamette Meridian, Linn County, Oregon, said point lying 35 feet west of the southeast corner of said Parcel "A"; thence west-northwesterly approximately 72 feet to a point on the south right-of-way line of Belmont Avenue, said point lying 105 feet west of the east property line of said Parcel "A". As shown on the attached map labeled Exhibit A.

Together with the right of access, for Grantee, its contractors, or agents, to the right of way from adjacent lands of the Grantor for all activities in connection with the purposes for which this easement has been granted; and together with the present and (without payment therefore) the future right to keep this right of way clear of all brush, trees, buildings and other hazards which might endanger the Grantee's facilities or impede Grantee's activities.


At no time shall the Grantor place or store flammable materials (other than agricultural crops), or light any fires, on or within the boundaries of the right of way. Subject to the foregoing limitations, the surface of the right of way may be used for agricultural crops and other purposes not inconsistent, as determined by Grantee, with the purposes for which this easement has been granted.

The rights and obligations of the parties hereto shall be binding upon and shall benefit their respective heirs, successors and assigns.
