NOTICE: PERMITS BECOME VOID IF WORK OR CONSTRUCTION AUTHORIZED IS NOT COMMENCED WITHIN 180 DAYS, OR IF CONSTRUCTION OR WORK IS SUSPENDED OR ABANDONED FOR A PERIOD OF 180 DAYS AT ANY TIME AFTER WORK IS COMMENCED. ELECTRICAL PERMITS ARE NON-TRANSFERABLE AND NON-REFUNDABLE.

MULTI-FAMILY DWELLINGS

In a multifamily dwelling with three (3) or more units, OAR 917-309-0030 (5)(b) requires the electrical permit fee to be calculated by taking the square footage of the largest unit in the building and computing the fee. A fee of one-half of the first unit fee is applied to all additional units in the building regardless of size. When requesting inspections, OAR 918-309-0030 (1) allows for up to four (4) inspections on a residential permit unless otherwise noted. The entire building is required to be ready for inspections or additional inspections charges will be charged.

In a multifamily dwelling with 3 or more units, OAR 918-309-0030 (3)(b) requires the limited energy permit to be calculated in the same method as the overall fee for multi-family residential construction.

LIMITED ENERGY

This permit is issued under OAR 918-309-0400. The applicant agrees to make only restricted energy installations (100 volt amps or less) under this permit and to do the following:

When required, installer must have electrical license. (Certain residential and other transactions are exempt from licensing. These have asterisks (*). All others require licensing.)

Call for an inspection when all of the installations under this permit are ready for inspection.

Purchase separate permits or pay for re-inspections for all installations that are not ready for inspection when the inspector is out to inspect under this permit.

Assume responsibility for assuring that all corrections required by the inspector are done.

Assume responsibility for calling for final inspection when all of the corrections are completed.

The person signing this permit must be the applicant or a person authorized to bind the applicant.
