ITEMS REQUIRED FOR SUBMITTAL WITH APPLICATION:

- Plan Review Fee: 40% of fire alarm permit (\$70.00 minimum fee)
- ONE** set of plans must be made available electronically to be used for electronic plan review **OR THREE** sets of paper plans.
- Electrical permit application (See reverse side of application)
- Floor plan drawn to scale
- Location of all alarm initiating and alarm signaling devices
- Alarm control and trouble signaling equipment
- Annunciation equipment location
- Battery calculations
- Conductor type and sizes with voltage drop calculations
- Specification sheets from the equipment manufacturer, along with model numbers and listing information for all equipment, devices, and materials
- Any additional information that may be required because of the characteristics of a project.
