



1. CALL TO ORDER

The meeting was called to order at 3:30 p.m.

2. APPROVAL OF MINUTES

MOTION: Lynn Whitacre moved to approve the August 13, 2013 minutes as presented. Chuck Leland seconded the motion, and it **passed** 6-0.

3. BUSINESS FROM THE PUBLIC

4. DISCUSSION ITEMS

a. Going to Pots
