ADDENDUM #1

SS-19-05-A, Riverfront Wet Weather Lift Station and Force Main Phase 2

In order to clarify the intent of the Specifications and Drawings, the following provisions are provided and shall be considered part of the contract documents.

In order to ensure that all bidders are aware of these provisions, each bidder shall sign this addendum below and attach it to the proposal.

IMPORTANT: Failure to include a signed Addendum could result in the disqualification of your bid.

BID OPENING DATE AND TIME:

The due date and bid opening has been rescheduled for **Tuesday, March 31, 2020, at 2:45 p.m.**

DEBARMENT AND SUSPENSION FORM (CLARIFICATION):

This project is funded by the Oregon Department of Environmental Quality Clean Water State Revolving Fund loan program. As a result, the City cannot award the project until DEQ has approved the Debarment and Suspension Form (provided in Appendix C). All Contractors and subcontractors with a contract value of \$25,000 or greater must have valid CAGE and DUNS numbers from the System for Award Management as described on the form. No additional payment or contract time will be provided for delays caused by the lack of CAGE or DUNS numbers.

NEW BID SUBMITTAL PROCESS See Addendum #3 for changes to this section.

City Hall will be open to the public by appointment only starting at 8:00 a.m. on Thursday, March 19, 2020. This temporary policy is in response to the COVID-19 virus and efforts to protect City employees and the public.

Contractors will be able to submit bids using one of the following procedures.

Bid Submittal Option 1 – Electronic:

- Email all submittal documents listed on the **BIDDER'S SUBMITTAL CHECKLIST** found on page 2 of the Contract Documents to pw.quotes@cityofalbany.net, by 2:45 p.m., Tuesday, March 31, 2020. A scanned copy of a bid bond is acceptable for the purposes of the bid opening. Original bid bonds must be submitted to City Hall by 10:00 a.m., Wednesday, April 1, 2020. Contractor must call 541-917-7676 to make an appointment to submit the original bid bond.
 - The body of the email shall plainly identify: (1) the project name, (2) the bid opening time and date, (3) the bidder's name, and (4) the contractor's license number.
 - Contractor shall be responsible for calling 541-917-7676 to confirm the City has received the bid.
- The bid opening may be delayed a few minutes to allow city staff time to open emails and print the electronically submitted bids.
- Email First-Tier Subcontractor Disclosure form to pw.quotes@cityofalbany.net by 4:45 p.m., Tuesday, March 31, 2020.
 - Contractor shall be responsible for calling 541-917-7676 to confirm the City has received the First-Tier Subcontractor Disclosure form.

Bid Submittal Option 2 – Appointment:

- An appointment must be made to enter City Hall to submit a hard copy bid. Call 541-917-7676 to make an appointment. Hard copy bids must be received by 2:45 p.m., Tuesday, March 31, 2020.
- An appointment must be made to enter City Hall to submit a hardcopy First-Tier Subcontractor Disclosure form. Call 541-917-7676 to make an appointment. Hardcopy First-Tier Subcontractor Disclosure forms must be received by 4:45 p.m., Tuesday, March 31, 2020.

NEW BID OPENING PROCESS

An in-person bid meeting will not be held at City Hall at the time of the bid opening. Instead, contractors may participate in a Meet-Me conference call at 2:45p.m., Tuesday, March 31, 2020, to listen to the bids being read.

As per usual, bid results will be posted on the City’s website.
