

RESOLUTION NO. 1498

( RESOLUTION AUTHORIZING CITY MANAGER TO GIVE ADMINISTRATIVE APPROVAL TO CERTAIN PUBLIC INTEREST GROUPS FOR USE OF PUBLIC RIGHTS OF WAY AND WAIVERS OF FEE )

WHEREAS, City Council of the City of Albany from time to time receives requests for encroachments on public rights of ways and waivers of fee by public interest groups and these matters should be treated on an administrative basis and only in unusual circumstances should the requests be necessarily referred to the City Council. Now, therefor,

BE IT RESOLVED by the City Council of the City of Albany that the following applications be considered and granted by the City Manager of the City of Albany, unless an unusual circumstance shall be determined to exist:

## 1) Kiwanis Circus

request of circus for waiver of one-half of business license fee for circuses.

## 2) Timber Carnival

Encroachment permit for princess booths on downtown sidewalks.  
Encroachment permit for right of way on the east side of Broadalbin between First and Second Avenues for concession booths during Timber Carnival parade.  
Request of Timber Carnival Parade Committee to use sound truck.  
Permit Takena Kiwanis to use one parking space in front of State Savings to sell popcorn during Timber Carnival Parade. The City Manager must be notified one week prior to above events each year.

## 3) Crazy Days

Encroachment permit for sidewalk sales.  
Closure of Broadalbin from First to Second Avenue and from Second to the alley between Second and Third Avenues. Subject to one week notification of City Manager. Give City Manager administrative responsibility over concessionaires.

## 4) Christmas

Retail Merchants Committee request for location of Santa Claus house in 200 block on West First Avenue ( City Parking lot ).  
Yuletiders request for waiver of meter hood fee during two week period prior to Christmas.

## 5) Spring Arts Festival

The Spring Arts Festival Committee requests use of the City Park between the Albany Civic Theater and the Lyon Street bridge.

Use of selected City Parking lots subject to approval by the Retail Merchants Committee.

Use of two Timber Carnival Princess booths to be placed on downtown sidewalks and used as information booths.

Use of two parking spaces in front of former Parrotts and Giles and waiver of usual hood fee.

Allow State Savings popcorn wagon to sell concessions either in the hooded meter spaces or in a City Parking lot ( with additional waiver of hood fee ).

Permission to place three banners across City streets and decorative banners on First Avenue meter posts.

note: for the 1973 Spring Arts Festival use of only the parking lot between Magoo's and the Ellsworth Street bridge is requested.

6) Request of American Red Cross for waiver of parking hood fee during those times when Bloodmobile is in operation.
