Resolution No. 2017

A Resolution to Establish Procedure for the Administrative Approval of Minor Partitions

WHEREAS , ORS 92.046, paragraph 3 authorizes the City Council to delegate authority to approve minor land partitions; and,

WHEREAS, Albany Municipal Code Section 02.24.040, paragraph B allows that the Albany City Planning Commission may establish procedures for the administrative approval of minor land partitions; and

WHEREAS, it is the Commission's desire to expedite the processing of minor land partitioning requests and eliminate any unnecessary burden upon public hearing bodies in needless review of routine matters; now, therefore,


BE IT RESOLVED by the City Council of the City of Albany that the Planning Director is hereby authorized to approve/deny requests for minor partitions of land in the City of Albany; that the standards for establishing such requests shall be the same as those applied to major subdivisions except in regards to street improvement and design; that upon approval/denial of any such partition, notice shall be published in a local newspaper of general circulation; and that interested parties have ten (10) days from the date of the decision to appeal the decision to the Hearings Board; and

BE IT FURTHER RESOLVED that the Planning Director may refer any minor subdivision having unique or unusual characteristics or problems to the Hearings Board for approval; and,

BE IT FURTHER RESOLVED that there is hereby established the fee of \$100 for the application for a minor land partition which shall be paid by the petitioner at the time of application, said fee to cover the cost of technical review of the proposed partitioning and the plan check fee of \$40 which portion of the fee will be reimbursed to the petitioner if the application is denied.


BE IT FURTHER RESOLVED that the appeal of the decision to the Hearings Board will be without charge.


