

RESOLUTION NO. 3436

A RESOLUTION PRESCRIBING PARKING REGULATIONS WITHIN THE DOWNTOWN PARKING AREA

WHEREAS, the City has heretofore enacted Ordinance No. 5156, amending Section 13.21 of the Albany Municipal Code and authorizing agreement with the Albany Downtown Association to manage parking areas under the ownership of the City and to enforce on street parking within certain areas; and

WHEREAS, the area subject to the management control of the Albany Downtown Association is described in Ordinance No. 5156 and, for purposes of this resolution, is hereinafter identified as the "Downtown Parking Area;" and

WHEREAS, the City has previously entered into an Agreement for Parking Management with the Albany Downtown Association whereby the Albany Downtown Association is given the authority to manage parking within the Downtown Parking Area; and

WHEREAS, the aforesaid Agreement for Parking Management calls upon the Albany Downtown Association to recommend specific limitations on parking duration applicable to on street parking locations within the Downtown Parking Area, which recommendations, if accepted, shall be approved by City Council Resolution; and

WHEREAS, the time limitations and regulations hereinafter set forth have been proposed by the Albany Downtown Association pursuant to the aforesaid Agreement for Parking Management.

NOW, THEREFORE, BE IT RESOLVED, as follows:

1. Four (4) Hour Customer Only Limited Time Zone. No person shall park, cause or permit to be parked any motor vehicle for more than four (4) hours within any 24-hour period in the following area, to-wit: parking lot located on South half of block on North side of First Avenue between Broadalbin and Ellsworth; the 25 spaces located on the Northeast side of First Avenue between Ellsworth and Lyon on Southwest corner of the block; the parking lot located at Two Rivers Mall between Ferry and Broadalbin, and Second and Third Avenue.

The area described above shall be an area designated for limited-time parking for purposes of the employee parking prohibition contained in Ordinance No. 5156.

2. Three (3) Hour Customer Only Limited Time Zone. No person shall park, cause or permit to be parked any motor vehicle for more than three (3) hours within any 24-hour period in the following area, to-wit: The West side of the street from Water Street to Second Avenue; East side of Broadalbin from Water Street to Fourth Avenue, omitting first three spaces between Third and Fourth Avenue on North end of the block; the West side of Broadalbin from First Avenue to Fourth Avenue, omitting the first four spaces between Third Avenue and Fourth

Avenue on North end of block; West and East sides of Ellsworth between First Avenue and Second Avenue and the West side of Ellsworth between Second and Third; West and East sides of Lyon Street between First and Third, omitting last two spaces on West side of Lyon between First Avenue and Second Avenue on South end of block and first two spaces on West side of Lyon between Second Avenue and Third Avenue on North end of block; last four spaces on East side of Lyon between Third and Fourth Avenue on South end of block; North side of First Avenue between Calapooia and Washington, both North and South sides of First Avenue from Washington to Baker, omitting last two spaces on South side of First between Ferry and Broadalbin on East end of block; North and South sides of Second Avenue from Washington to Lyon, omitting first space at all four corners of intersection at Ellsworth and Second Avenue, and omit last space on North and South sides of Second Avenue on West side of Lyon; North side of Second Avenue between Lyon and Baker; first four spaces on South side of Third between Ferry and Broadalbin on West end of block; North side of Third between Broadalbin and Ellsworth; first two spaces on South side of Third between Ellsworth and Lyon on West end of block; South side of Fourth Avenue between Ferry and Ellsworth omitting last seven spaces between Broadalbin and Ellsworth on South side of Fourth on West end of block; North side of Fourth Avenue between Broadalbin and Ellsworth; South side of Fourth Avenue between Ellsworth and Lyon on East end of block along side of Armory.

The area described above shall be an area designated for limited-time parking for purposes of the employee parking prohibition contained in Ordinance No. 5156.

3. 30-Minute Customer Only Limited Time Zone. No person shall park, cause or permit to be parked any motor vehicle for more than thirty (30) minutes within any 24-hour period in the following area, to-wit: North side of Second Avenue between Calapooia and Washington; first spaces on all four corners at intersection of Ellsworth and Second; last space on North and South sides of Second Avenue on West side of Lyon; single space on West side of Washington between Second Avenue and Third Avenue South of alley; first single space on South side of Third Avenue between Washington and Ferry on West end of block; first four spaces on West side of Ferry between Third Avenue and Fourth Avenue on North end of block; two spaces on West side of Lyon between Fourth Avenue and Fifth Avenue on North end of block; last two spaces on West side of Lyon between First Avenue and Second Avenue on South end of block.

The area described above shall be an area designated for limited-time parking for purposes of the employee parking prohibition contained in Ordinance No. 5156.

4. 10-Minute Customer Only Limited Time Zone. No person shall park, cause or permit to be parked any motor vehicle for more than ten (10) minutes within any 24-hour period in the following area, to-wit: Two spaces on South side of First Avenue on East side of block between Ferry and Broadalbin; East side of Ellsworth between Second and Third Avenue; first three spaces on West side of Ellsworth on North end of block between Third Avenue and Fourth Avenue; first two spaces on East side of Ellsworth on North end of block between Third and Fourth Avenue.

The area described above shall be an area designated for limited-time parking for purposes of the employee parking prohibition contained in Ordinance No. 5156.

5. All Day Free Customer and All Day Employee Permit Only Parking: No person other than a customer or patron of a merchant, service provider or governmental entity located within the Downtown Parking Area shall park, cause or permit to be parked any motor vehicle for more than twelve (12) hours within any 24-hour period in the area described below unless that person has, properly displayed upon the vehicle, a current permit issued by the City of Albany, the Albany Downtown Association or such other entity as may be contracted with for management of parking within the Downtown Parking Area, permitting said parking.

The area designated for all day free customer and all day employee permit only parking is as follows, to-wit:

Calapooia: Both sides of Street from Willamette River to Third Avenue; **Washington:** East and West sides of Washington from Willamette River to Fifth Avenue with exception of single space on West side of street between Second and Third on South side of alley; **Ferry:** East side of street from Water Street to Second Street; West side of Ferry between Second and Third; West and East sides of Ferry from Third to Sixth Avenue with exception of first four spaces between Third and Fourth on West side of street at North end of block; **Broadalbin:** West side of street between Water Street and First Avenue; first four spaces on West side of street between Third and Fourth on North end of block and first three spaces on East side of street between Third and Fourth on North end of block; both sides of street between Fifth and Sixth; **Ellsworth:** Single space on South end of block between Third and Fourth on West side of street; three spaces on East side of street between Third and Fourth on South end of block; both sides of street from Fourth Avenue to Ninth Avenue; **Lyon:** Two spaces on West side of street between Second and Third on North end of block; both sides of street from Third to Ninth with exception of four spaces on South end of block between Third and Fourth on East side of street and two spaces on North end of block between Fourth and Fifth Avenue on West side of street; **Baker:** Both sides of Baker from Water Street to Second Avenue; **Montgomery:** Both sides of Montgomery from Water Street to Fourth Avenue; **First Avenue:** Both sides of street between Baker and Railroad Street; **Second Avenue:** South side of street from Lyon to Baker; both sides of street from Baker to Railroad Street; **Third Avenue:** Both sides of street from Calapooia to Ferry except single space on South side of street on West end of block at Washington intersection; four spaces on South side of street between Ferry and Broadalbin on East end of block; North side of street between Ferry and Broadalbin; South side of street between Broadalbin and Ellsworth; both sides of street from Ellsworth to Montgomery with exception of two spaces on South side of street between Ellsworth and Lyon on West side of block; **Fourth Avenue:** Both sides of street from center of block from Calapooia to Ferry; first five spaces on North side of street between Ferry and Broadalbin on West end of block; six spaces on South side of street between Broadalbin and Ellsworth on East end of block; both sides of street from Ellsworth to Montgomery with exception of spaces along side of Armory on South side of street between Ellsworth and Lyon on East end of block; **Fifth Avenue:** Both sides of street from Washington to Baker; **Sixth Avenue:** Both sides of street from Ferry to Lyon; **Seventh Avenue:** Both sides of street from Ellsworth to Lyon; **Eighth Avenue:** Both sides of street from Ellsworth to Lyon; **Ninth Avenue:** Both sides of street from Ellsworth to Lyon.


Nor shall any employee who is prohibited from parking in a limited time area pursuant to Ordinance No. 5156 park in the area described above unless that person has, properly displayed upon the vehicle, a current permit issued by the City of Albany, the Albany Downtown Association or such other entity as may be contracted with for management of parking within the Downtown Parking Area, permitting said parking.

6. Free Employee Parking. The City-owned parking lot located on North side of Water Street between Ferry Street and Broadalbin Street shall be provided for free parking by employees working in the Downtown Parking Area.

7. Leased Employee-Only Parking. The City, the Albany Downtown Association or any other entity within whom the City contracts for the management of parking within the Downtown Parking Area shall provide individually leased parking spaces in the area described below and no person other than the duly authorized lessee of the space, in compliance with the terms of their lease, shall park, cause or permit to be parked any motor vehicle in said space, to-wit: Spaces on South side of Water Street between Ferry and Broadalbin; lot on North half of block between Ferry and Broadalbin; lots on North half of blocks between Broadalbin and Lyon.


8. Posting of Signs Permitted. The City, the Albany Downtown Association or any other entity within whom the City contracts for the management of parking within the Downtown Parking Area is duly authorized to post and maintain signs throughout the Downtown Parking Area which comply with the limitations and regulations set forth in this resolution. Parking a vehicle in violation of any sign posted in accordance with the terms of this resolution shall be a violation of AMC 13.21.050 and punished accordingly. In addition, the time limitations set forth herein shall prescribe parking time limitations in accordance with AMC 13.21.040.
