

A RESOLUTION APPROVING EXEMPTION FROM THE COMPETITIVE BIDDING REQUIREMENTS FOR THE PURCHASE OF ONE VAC-CON COMBINATION JET/VACUUM SEWER CLEANER THROUGH A CONTRACT WITH NATIONAL JOINT POWERS ALLIANCE (NJPA) AND ATLANTIC MACHINERY, INC.; ISSUING A NOTICE OF INTENT TO AWARD CONTRACT WITH ATLANTIC MACHINERY, INC.; AND AUTHORIZING THE PUBLIC WORKS DIRECTOR TO ENTER INTO A CONTRACT WITH ATLANTIC MACHINERY, INC., NOT TO EXCEED \$299,950.00.

WHEREAS, National Joint Powers Alliance (NJPA), Staples, Minnesota, allows local government access to competitively bid contracts using an interstate cooperative procurements pursuant to ORS279A.220 and OAR 137-046-0400 to 0480; and

WHEREAS, the City Council approved a request for membership with NJPA at the October 9, 2013, City Council meeting; and

WHEREAS, NJPA conducted a formal competitive Request for Proposals, RFP No. 011510, and advertised the solicitation in the Daily Journal of Commerce in Oregon, and

WHEREAS, NJPA, awarded the contract to Atlantic Machinery, Inc., Contract No. 031710-AMI, to provide Public Utility Equipment – Sewer Vacuum Trucks through Vac-Con, Inc.; and

WHEREAS, Atlantic Machinery, Inc.'s local representative, Enviro-Clean Equipment, provided the City with a quote that included a trade-in allowance for the replacement Vac Truck; and

WHEREAS, NJPA's cooperative contract provided the best value, (lower cost and a trade-in allowance) in comparison to other cooperative contracts and vendor quotes; and

WHEREAS, the Public Works Department is prepared to issue a Notice of Intent to Award the purchase of one Vac-Con Combination Jet/Vacuum Sewer Cleaner; and

WHEREAS, the Notice of Intent has to be advertised seven days prior to awarding the purchase; and

WHEREAS, if the City does not receive any formal protests to the Notice of Intent to Award, the Public Works Director may award the purchase of a Vac-Con Combination Jet/Vacuum Sewer Cleaner to Atlantic Machinery, Inc.


NOW, THEREFORE, BE IT RESOLVED that the Albany City Council authorizes the Public Works Department an exemption from the competitive bidding process for the purchase of a Vac-Con Combination Jet/Vacuum Sewer Cleaner through a cooperative contract with NJPA and Atlantic Machinery, Inc.; and


BE IT FURTHER RESOLVED that the Albany City Council authorizes the Public Works Department to issue a Notice of Intent to Award Contract with Atlantic Machinery, Inc.; and

BE IT FURTHER RESOLVED that the Albany City Council authorizes the Public Works Director to enter into a contract not to exceed \$299,950.00 with Atlantic Machinery, Inc., to purchase a Vac-Con Combination Jet/Vacuum Sewer Cleaner, subject to no formal protests during the seven-day Notice of Intent to Award Contract.
