Additionally, there may be persons at the City of Albany program, rental, reservation, or permitted event ("City Facility or Event") that are not complying with the Guidelines.

The City of Albany cannot guarantee that you and those that you later come in contact, e.g., your child, family, or others, will not become infected with COVID-19 by your attending or participating in a City Facility or Event.

READ AND INITIAL EACH ITEM

A. COMPLIANCE WITH OHA COVID-19 GUIDELINES

_____ While using, renting, organizing and/or participating in any "City Facility or Event", **I will, and I will require those attending or participating** (including spectators) to comply with the Guidelines and regulations set forth by the Oregon Health Authority.

B. WAIVER, RELEASE, AND INDEMNIFICATION OF RISKS FROM COVID-19

_____ I acknowledge the highly contagious nature of COVID-19 and voluntarily assume the risk that I and other attendees and participants in the City Facility or Event may become exposed to or infected with COVID-19, and that if infected may transmit, expose, or infect others.

_____ I understand there is a risk of becoming exposed to or infected by COVID-19 at a City Facility or Event due to the actions, omissions, or negligence of myself and others, including, but not limited to, City employees, volunteers, agents, and other participants and attendees.

_____ I voluntarily assume the risk that such exposure or infection may result in liabilities, losses, damages of any kind, and my personal injury, illness, permanent disability, and death, and that third parties may also become exposed and infected by transmission from me and suffer the listed results ("COVID-19 Result").

_____ I waive, release, indemnify, hold harmless, defend, covenant not to sue, acquit, and forever discharge, the City of Albany and all officials, employees, officers, and agents from and against a COVID-19 Result, including any and all rights of action, claims, demands, liabilities, directly or indirectly arising in whole or in part from attending or participating in a City Facility or Event.

_____ The City of Albany assumes no liability whatsoever related to COVID-19 or to any COVID-19 Result.

If this document is executed on behalf of an entity, "I" includes the Organization and "me" or "my" includes the Organization's members and persons attending or participating in the Organization's use of a City Facility or participation in a City Program or Event.
